Following the outbreak of World War II, a German company executive named Hans Ferdinand Mayer took what he claimed was an ordinary business trip to Oslo, Norway. The true purpose of his journey, however, was to leak highly classified information to Nazi Germany's adversary, Britain. In Norway, Mayer wrote what has become known as the Oslo Report, providing details of Germany's military capabilities and technology, including the fact that Germany had developed a radar system. Britain possessed this technology but erroneously believed that Germany did not, so it was unaware that Nazi radar systems could potentially give them advance warning of bombing raids carried out by British planes.

Initially, however, there was skepticism regarding the report. Although Mayer provided detailed evidence that his information was correct, the British were suspicious that it was a German deception. The document had been sent anonymously, and it seemed impossible that German technology had advanced so rapidly. However, a military intelligence officer named R. V. Jones realized the report was accurate and convinced the British of its validity. Eventually, the information in the Oslo Report was incorporated into military strategy and used to develop measures aimed at countering German weapons systems.

Scientists generally agree Earth has experienced five mass extinction events. These socalled Big Five events fit the general criteria for recognition as mass extinctions: they wiped out at least three-quarters of species, and they occurred on a rapid timescale. While such events devastate life on Earth, they also reshape ecosystems so fundamentally they create possibilities for certain species to thrive. In the second mass extinction, for example, which occurred around 370

million years ago, the disappearance of reef systems caused changes in habitat space and water circulation that allowed starfish-like organisms called crinoids to populate the ocean in extremely large numbers.

Some scientists believe that, due to human activity, a sixth mass extinction event is occurring. They note that extinction rates of plants and invertebrate animals exceed the normal rate at which species disappear between mass extinction events. The scientists say critics of the sixth mass extinction theory rely too much on the IUCN Red List, a global inventory that reflects extinction data for only a limited range of species encompassing mainly birds and mammals. They say when smaller, lesser-known organisms are accounted for, the degree of biodiversity loss signals that the sixth mass extinction is indeed underway.

#### $\Re(\mathbf{C})$ Incan Agriculture

Despite the rugged terrain of the Andes Mountains where they lived, the Incan people cultivated large areas of land for agriculture. In addition to breeding crop varieties that could withstand the severe climatic conditions, the Incas also developed innovative farming methods. These included terraced fields, complex irrigation systems to provide water, and stone walls that trapped heat to protect crops from frost. Using these methods, the Incas were able to create stockpiles of food that could be used in case of poor harvests and other crises. Many historians believe this was a major reason the Incan Empire could become so powerful.

Following the arrival of the Spanish in the sixteenth century, the Incas' agricultural systems fell into disrepair, and most of their farming knowledge and expertise was eventually lost. Over the past few decades, however, a charity organization has been using archaeological information to rehabilitate farmland in Peru using Incan methods. The project has been a success, increasing agricultural production in an area that covers over 150 hectares. It is now hoped that similar projects can be set up in other parts of Peru to help overcome the effects of climate change on agriculture in the region.

The marshes of southern Iraq have long been regarded as ecologically significant. Despite encroaching development, such as agricultural and irrigation projects, a significant proportion of the wetlands remained intact for much of the twentieth century. In the 1990s, however, the president of Iraq ordered the marshes to be systematically drained of their water. This action was, in part, seen as a political move to punish groups that the government saw as hostile. Such was the devastation to the marshes that they were reduced to a small fraction of their historical size. Many Marsh Arabs, whose families had lived in the region for generations, were forced to flee.

In the early 2000s, a change of government provided an opportunity to reverse the marshes' fortunes. With support from the United Nations, among others, some areas were reflooded. Nature returned, and so did some Marsh Arabs. To help ensure the marshes' ongoing protection, some of them were awarded World Heritage status. Despite the program's success, some observers believe dark times loom. The expansion of agricultural land, the creation of upstream dams, and recent droughts threaten to undo the progress made. Some areas have already dried up, making fishing and other life-supporting activities impossible.

#### $\star$ (E) The Judgement of Paris

The seventeenth-century Flemish artist Peter Paul Rubens is well-known for his paintings of human figures. One of his most famous and best-loved masterpieces, *The Judgement of Paris*, is currently back on display at the National Gallery in London after undergoing a year of conservation work. However, the painting no longer looks the way that Rubens intended. During the conservation process, the gallery's experts discovered that several changes had been made to the painting after Rubens's death, including major alterations to the appearance of the main characters in the painting.

Following much debate, the gallery decided to preserve the changes, arguing that they represented an important part of the painting's history. In fact, while altering an artist's original work is generally considered unthinkable today, it was a relatively widespread practice in the past. Paintings were seen as decorative objects, and their owners would often have them changed simply to make them more attractive. Potentially offensive scenes, such as those containing violence or nudity, were also removed from paintings to make them more palatable for polite society. In the case of *The Judgement of Paris*, it is believed that the changes were made to make it more appealing to the art market at the time.

**Interviewer (I):** Serena, thanks for joining me today. Let me start by asking how you became interested in urban planning.

**Serena Marlow (S):** As a curious teenager, I loved exploring different neighborhoods in my city, some steeped in history with buildings going back hundreds of years and others that had undergone urban regeneration and were dominated by glass-and-steel skyscrapers. When college came around, I decided to get a degree in urban design, and I've never looked back.

**I:** Interesting. Now, my understanding is that your work projects are relatively small in scale. Is that right?

**S:** Yes. Sustainable community-based projects are my specialty. I focus on redesigning areas to create accessible, welcoming spaces that employ eco-friendly materials while ensuring a sense of continuity by preserving aspects of an area's character that residents hold dear. I'm careful to only take on work that fits my philosophy regarding sustainable and livable urban communities. The last thing I want to do is be part of a project that bulldozes its way—literally or metaphorically—through a community.

I: What's one of the biggest challenges you face?

S: There are myriad issues to juggle. I spend a lot of time hunched over my computer, but I also have to meet with the primary investors, visit construction sites, and attend public hearings about new developments. Opposition to developments is par for the course, and it's essential to persuade local people of the gains to be had. People are often set in their ways—they understandably fear change and are worried about losing community cohesion. So, this is probably the hardest aspect of my work. I have witnessed some real hostility at times, but the key is to engage early, listen to residents' concerns, and incorporate their feedback.

I: I see. Can you tell us about any recently completed projects?

S: Sure. I've just wrapped up a collaboration with a local town council to redevelop a neglected waterfront area into a vibrant public space. This involved gauging the needs of the local community, which has become much more diverse in the last thirty years due to immigration, as well as keeping to a strict budget and consulting with environmental and safety experts. The result is a new Victorian-style promenade, in keeping with the character of nearby historical buildings. The promenade then seamlessly blends into a park planted with native trees for shade. The park is interspersed with maritime-themed sculptures, and there are also information plaques that provide a link to the town's history and acknowledge the contributions of more-recent arrivals. It's become a focal point for families to congregate around. The benches and tables are laid out in a way that encourages communication, and some people say it's helped break down cultural barriers in the community and given them the chance to expand their circle of friends.

I: Finally, how have developments in tech helped or hindered your work?

S: Technology has always been important, but the capabilities of recent technological developments are truly transformational. For example, geographic information systems manage and analyze all kinds of spatial data, allowing us to make informed decisions regarding development. Also, 3D modeling and simulations give us huge insights into potential final

outcomes, which allows us to tweak projects before they are built. AI is having a massive impact, and I expect that to continue. Some people fear it, but I see it as another weapon in our arsenal, helping automate many tasks, bring more efficiencies, and ultimately make urban life more sustainable than ever.

I: Well, thank you for your time, Serena.
